ITEM 2: Presentation of Reports

CEO Report – CEO opened review by highlighting item 21. Maverick County Hospital District was able to address the efforts of provider recruitment and the challenges MCHD faces. CFO reported on MCHD October financials. CFO highlighted significant improvement for payments from last year of 21% (\$691,000) for the month of October. Significant increase in visits from prior year, 20% increase. Primary care and specialty care combined is meeting the goal for the 2nd week of the fiscal year.

COM Report- COM reported on all the events MCHD was able to participate in. MCHD attended the Think Pink Event for the MCHD BCCS Program on October 5, 2022. Mammogram Mobile Clinic – MCHD partnered with Bexar Imaging from October 10th- 14th to provide screenings for women over 40 years of age. Keep Healthy – MCHD attended the Keep Healthy fair on October 13, 2022 and provided blood pressure screenings, glucose screenings, and body max index. Blood drive – MCHD hosted Blood Drive on November 1, 2022. MCHD also participated in the Medical Career Expo, Pride Parade in support of Ryan White Program, and the San Felipe Del Rio CISD annual health fair. MCHD participated in a Fire safety training with the Fire Marshall.
